**1. CALL TO ORDER**

**3. TOWN MANAGER REPORT**

Town Manager Billings informed the Harbor Committee members on the progress of the Dredging project. Letters have been mailed to Senator Collins, Snowe, Michaud and Damon, Representative Pingree and Governor Baldacci. Mark Habel has emailed Town Manager Billings forms to fill out in order to be eligible for 2007 funding.

Town Manager Billings has contacted Tom Benson to do survey work.

**4. HARBOR MASTER REPORT**

Stewart Murphy has been hired as the new Tremont Harbor Master. He reported that Jimmy Schlaefer has done alot of work on the Harbor Master boat, and should be completed soon.

Harbor Master Murphy would like to see a moratorium placed on issuing new mooring spots until the dredging project is complete. All moorings will have to taken out and replaced after the dredging is over. Harbor Master Murphy would like to have a new GPS system. The mooring map that we have now is out of date and needs to be done over, the GPS will make placement of mooring alot easier to plot.

There was some discussion on the parking issues in the Bernard parking lot; the Selectmen will revisit this issue in October. Right now the Selectmen and the Harbor Committee are researching other alternatives. Harbor Committee members don't want to see Bernard to turn into a huge parking lot. Gott's Island residents have been presented with parking options from Morris Yachts, residents don't want to pay for parking. Another issue to be addressed is the parking of renters on Gott's Island during the summer months.
