  - A. **BIDS WHARF HOUSE SIDING PROJECT**

  - B. **BIDS WHARF HOUSE MATERIAL AND REPAIR PROJECT**

Dean Tozier motioned to send the bid to the Harbor Committee for review; Scott Grierson seconded, unanimous.

Scott Grierson motioned to schedule two public hearings to see if the citizens of the Town of Tremont feel there is a need for a Town wide noise Ordinance. Stewart Murphy from the Harbor Committee told the Selectmen that the Harbor Committee voted to recommend to the Selectmen that they spend up to \$3000.00 for a new center hoist on the wharf. Stewart said that the new hoist would correct all the problems that they have had.

Charlie Dillon motioned to allow up to \$3000.00 to be spent on center hoist, Dean Tozier seconded, unanimous.

Scott Grierson mentioned that the Harbormaster shack needs to be re-shingled. Stewart Murphy mentioned that some thought had been given to putting on a metal roof which the Harbormaster can do himself. Charlie Dillon mentioned a citizen that was in the Town Office who was very upset at being asked to park in the upper lot at the wharf. He wanted to register a one-foot boat to get his parking permit. Selectmen agreed that this may need to be addressed in the Wharf Ordinance.

It was also noted that the Harbor Committee needs to update the Harbormaster on certain procedures.
