Emergency Selectman's meeting of Thursday, June 12, 2014 was called to order at 3:00PM by Chairman Kathi Thurston.

Much discussion from concerned Residents

Mount Desert Islander Reporter Mark Good asked why the meeting was in executive session when it is obviously a personnel matter concerning the Town Manager. Town Attorney James Collier responded that he would disagree with Mr. Good. Not a personnel issue, if the Town Manager resigns the Board will have to figure out what to do. Mr. Good asked "Aren't things in the law, isn't the process spelled out?" To which Mr. Collier responded "No".

Town Manager Carl Young asked that for the record his statement was not that he would resign; his statement was that he intended to ask the Select Board to honor the agreement in number 14 of his contract.

Town Attorney James Collier responded that it amounts to the same thing.

After much discussion Selectman Stewart Murphy amended his motion to say "possible unemployment of Town Manager" instead of "possible resignation of the Town Manager, seconded by Selectman Bobby Lee. Motion passed 5-0. Selectmen voted unanimous to go into executive session at 3:34PM.
